Terms of Payment

Cancellation by the course participant

The course place is definitely reserved upon receipt of the written registration of the interested party. In the event of cancellation within the 6th to 2nd week before the course begins, half of the course fee will be refunded or is due. Any cancellation fees on the part of AlohaSpirit GmbH can be added to this.
